### General information and instructions for Power of attorney Estate

- The power of attorney applies only to the attorney-in-fact's right to represent the grantor of the power of attorney in matters concerning the estate.
- The power of attorney only applies with a registered estates inventory for the deceased and where applicable a valid will.
- The estate is represented by all beneficiaries jointly. These are shown in a registered estates inventory. The beneficiaries could be changed by a valid will.
- All beneficiaries are to be represented by an attorney-in-fact who can submit the original of the power of attorney if the distribution of the estate is to be executed by the bank.
- The bank reserves the right to determine whether a power of attorney can be approved.
- If the grantor is living abroad, the power of attorney must be attested and signed by recipient bank, a Swedish Embassy/Consulate or Notary Public.

### Instructions for completion of power of attorney

- The names, addresses, personal identification numbers and telephone numbers of the Grantor of the power of attorney and the Attorney-in-fact are to be provided in the designated boxes.
- The estates current address and the personal identification number of the estate is provided.
- The grantor of the power of attorney must personally sign the power of attorney and print his or her name.
- The signature of the grantor of the power of attorney must be witnessed by two persons.
- The witnesses certify that the grantor of the power of attorney signed the power of attorney and provide their printed names, addresses and telephone numbers.

### PROCESSING OF PERSONAL DATA

The personal data in respect of the grantor of the power of attorney and the attorney-in-fact which is submitted to the bank in this power of attorney will be processed in computer systems at the bank and at its subsidiaries in the Swedbank group of companies to the extent necessary to provide and administer the products and services covered by the power of attorney. It may also happen that the personal data is processed in computer systems at companies and organisations with wish the bank and the companies in the Swedbank group of companies cooperate in respect of the services in question. However, personal data will only be released if permissible in light of bank secrecy rules. Information regarding processing of personal data is available at the bank's branches, which also receive requests for correction of personal data.
